<p>-Schedule 40 PVC, 4-inch minimum required for sewer connection with clean outs every 75'. Sewer hook ups must be tested in accordance with the Minnesota Plumbing Code and pass an air test @ 5 PSI constant pressure for fifteen (15) minutes</p> <p>-1" copper water type "K" pipe minimum or 1" polyethylene plastic pipe (CTS)(SDR 9) w/tracer wire and access boxes are required for a water connection. Water hook ups must be air tested @ 100 PSI constant pressure for five (5) minutes or water tested by turning on the curb stop at the main</p> <p>-Contractors are responsible for scheduling inspections before any trench is backfilled. These appointments may be scheduled by calling (651) 464-4349. Only contractors licensed by the City can perform work in the City right-of-way</p> <p>I hereby certify that I have read and examined this application and know the same to be true and correct.</p>
